## COMPOSITION

Each softgel contains: Active ingredients: Vitamin E 5 IU, Folic acid 400 mcg, Vitamin B12 25 mcg, Biotin 200 mcg, Vitamin B5 25 mg, Calcium 50 mg, Iron (Ferrous fumarate) 5 mg, Magnesium 30 mg, Zinc 10 mg, Selenium 25 mcg, L-Methionine 25 mg and Omega 3 250 mg.

## PHARMACOLOGICAL CLASSIFICATION

## INDICATIONS

This product is a daily multivitamin supplement, enriched with vital vitamins, minerals and omega 3 fatty acids. It contributes to the maintenance of healthy hair, skin and nails.

## CONTRA-INDICATIONS

Do not use this medicine if you are hypersensitive (allergic) to any of the ingredients, fish or iodine. Not suitable for use in children under 12 years, unless under medical supervision.

## WARNINGS AND SPECIAL PRECAUTIONS

If you suffer from any serious ailments or conditions (such as Leber disease); or if you are taking any prescribed medication, please check with your healthcare provider before taking this medicine.

- No studies on the effect on the ability to drive and use machines have been performed. Please exercise care when driving or operating machinery until you know how it affects you.

In case of an overdose, or if an overdose is suspected, contact your healthcare provider immediately. Treatment is symptomatic and supportive.

## INDIKASIES
